2. The Competent Authority reserves the right to cancel a part or whole of this recruitment exercise, pending publication of final result.

#### **A. ESSENTIAL EDUCATIONAL QUALIFICATION:-**

1. A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of Educational qualifications included in Part II of the Third Schedule should also fulfil the conditions specified in sub- section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
2. Post-graduate Degree or Diploma in the concerned Speciality or Super-Speciality mentioned in Section-A or Section-B in Schedule-VI of National Medical Council.
3. **Three years experience in the concerned speciality after obtaining the first Post-graduate Degree or 5 years' experience after obtaining the Post-graduate Diploma.**

#### **B. DEADLINE FOR SUBMITTING APPLICATIONS**

Last Date of submission of application is on or before 24/10/2023 till 06:00 pm.

#### **C. MODE OF APPLICATION**

Through Online Mode only. The link for applying application is as <https://forms.gle/7hPJzaq5emFSdvYF8> After submitting application the candidate will receive an auto generated mail which will contain prefilled application form based on data submitted by the candidate. Shortlisted Candidates are required to bring a printout of the same along with photocopy and original of all the documents on the day of interview.

#### **D. MODE OF SELECTION**

The selection will be through interview basis only.

#### **E. DATE OF INTERVIEW**

The LIST OF SHORLISTED CANDIDATES will be displayed on website [www.burari.delhi.gov.in](http://www.burari.delhi.gov.in) and <https://health.delhi.gov.in> with the date & time of interview.

#### **F. AGE**

Candidate shall not exceed age 45 years on the last date of application submission.

Age relaxation will be as per extant rule for candidates belonging to Reserved (SC/ST/OBC/PWD/ EWS) Category.

#### **G. GENERAL TERMS AND CONDITIONS.**

1. Consolidate Remuneration : Rs.1,15,361/- per month
2. Agreement in the standard prescribed format shall be signed and executed by the contractual Specailist and the Medical Director.
3. The selected Specialists on contractual basis shall submit two original sets of signed contractual agreement within seven days of the receipt of letter which shall constitute,
4. acceptance of the offer on the terms and conditions specified. They shall also furnish an undertaking for not representing for extension of contract beyond 01 year.
5. If the contractual Specialists neither accept nor seek time to accept the offer within the prescribed limit of 7 days, the offer will be cancelled automatically and an offer would be given to the next on the waiting list.



6. Any letter of resignation submitted by the contractual specialists will be treated as a letter communicating the intention of the contractual doctor to terminate the contract. If a contractual specialists wishes to terminate the contract by giving one month's notice it would be accepted by the Medical Director of the institution, after getting a no dues certificate from the branches concerned. No Notice is required, if service is terminated on disciplinary grounds.
7. The contract may be terminated by either side with one month's notice or salary in lieu thereof. Private practice of any kind is not allowed.
8. Contractual specialists are governed only by the terms and conditions mentioned in the contract agreement and not by any other rules for grant of leave benefits, LTC benefits, GPF, Pension benefits, DGHS, Provisions of FR/SR etc., that are applicable to only regularly appointed doctors of Government of NCT of Delhi. It is therefore, incumbent upon them not to entertain any request for grant of benefits that are not covered under the terms of contractual agreement.
9. The timings of work of contractual engagement would generally be same as those of regular appointed specialists.
10. Specialists engaged on contract basis on consolidated pay will not be entitled for any allowances, financial benefits or concessions of medical facilities as admissible to regular Government Doctors.
11. Since contractual specialists are engaged against a vacant post of the particular institution, request for transfer to another hospital or dispensary shall not be considered.
12. The above posts shall be filled on regular basis through UPSC and the contractual doctors will have no claim on regular recruitment solely because of contractual engagement served at Burari Hospital, Burari .
13. SC/ST certificates issued only from Competent Judicial/Revenue authorities shall be accepted.
14. For candidates applying for OBC/EWS category, the certificate must be issued by the Competent Authority of Govt. of NCT of Delhi. Further the certificate must have been issued on or before the submission of application by the candidate.
15. OBC/EWS certificates issued from Govt. of NCT of Delhi shall only be accepted.
16. OBC/EWS certificate should mention the candidate belonging to Non-Creamy Layer for financial year 2022-23/2023-24.
17. In case of EWS the engagement is provisional and is subject to the Income and Asset certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake /false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of fake/false certificate.
18. Candidates should have valid DMC Registration Certificate which should include PG degree. DMC Acknowledgement receipt is also accepted.
19. Copies of Aadhar Card/ Voter ID Card/ Passport/ Driving License/etc. shall only be considered as proof of Residence.
20. Number of the vacancies is provisional and subject to change without any notice.
21. The appointed candidate will not be entitled to any kind of accommodation and other concessionary allowances.
22. The Candidates must bring the Original Certificates at the time of Interview for Verification.
23. No TA/DA will be paid for appearing in the interview.
24. ENGAGEMENT SHALL BE SUBJECT TO MEDICAL FITNESS AND VERIFICATION OF CERTIFICATES/DOCUMENTS. ANY CANVASSING BY OR ON BEHALF OF THE CANDIDATE OR ANY OUTSIDE INFLUENCE IN ANY FORM WITH REGARD TO SELECTION WILL LEAD TO DISQUALIFICATION.



25. The assessment of each shortlisted candidate shall be conducted through Interview Board constituted by the Competent Authority.
26. The appointment will be terminated at any stage if any declaration/ information furnished is found false or any material/fact is suppressed wilfully.
27. The decision of the Selection Board regarding selection of the candidates will be final and no representation will be entertained in this regard.
28. The candidates should not have been convicted by any court of law.
29. In case of any legal dispute, the jurisdiction of court will be Delhi/New Delhi only.
